

- Where the specialist fails to inform BUREAU VERITAS of any alterations in procedures;
- Where intermediate audit, if requested, has not been carried out;
- Where willful misrepresentations or omissions are ascertained.

BUREAU VERITAS reserves the right to cancel the approval and to inform the IACS Members accordingly. Should your approval be canceled, you may apply for re-approval after corrective actions for the reasons for cancellation have been implemented to the satisfaction of BUREAU VERITAS.
